THE TRANSPORT LICENCING (MOTORCYCLES AND
TRICYCLES) (AMENDMENT) REGULATIONS, 2017

1. These Regulations may be cited as the Transport Licensing (Motorcycles and Tricycles) (Amendment) Regulations, 2017 and shall be read as one with the Transport Licensing (Motorcycles and Tricycles) Regulations, 2010 hereinafter referred to as the “principal Regulations”.

Amendment of
regulation 5

2. Regulation 5 of the principal Regulations is amended by deleting paragraphs (b), (d), (g) and (h).

Amendment of
regulation 6

3. The principal Regulations are amended by deleting regulation 6 and substituting for it the following:

“Issuance of a
road service
licence

6. A local government authority or any other agent approved by the Authority may issue a road service licence upon being satisfied that the applicant:

- (a) has complied with the conditions stipulated under regulation 5; and

(b) has paid the fees prescribed in the Second Schedule to these Regulations.”

Amendment of regulation 13

4. Regulation 13 is amended by deleting paragraphs (l) and (m) and substituting for them the following:

- “(l) the motorcycle or tricycle has original valid insurance policy with the minimum requirement of third party liability which corresponds with the number of passengers as indicated in the motorcycle or tricycle registration card; and
- (m) the driver has a valid driving licence with the appropriate class.”

Amendment of regulation 27

5. The principal Regulations are amended by deleting regulation 27 and substituting for it the following:

“Review
GN. No. 15 of 2008

27. A person who is aggrieved by the decision of the Authority under these Regulations may, within fourteen days from the date of the decision, apply to the Authority for review, in accordance with the SUMATRA (Complaints and Review Procedure) Rules.”

Amendment of regulation 29

6. The principal Regulations are amended by deleting regulation 29 and substituting for it the following:

Transport Licencing (Motorcycles and Tricycles) (Amendment)

“Compounding of offences

29.-(1) The Authority may compound offences as specified in the Third Schedule to these Regulations.

(2)

Notwithstanding sub-regulation (1), compounding amount of offences under these Regulations, shall be as provided in the Third Schedule.”

Addition of new regulations 30, 31, 32,33 and 34

7. The principal Regulations are amended by adding immediately after regulation 29 the following new regulations:

“Notification of offences

30.-(1) The Authority shall, after identifying the offence contravening these Regulations, notify the offender electronically or manually in the Notification Form prescribed in the Fourth Schedule and Fifth Schedule to these Regulation on the-

- (a) offence committed;
- (b) penalty under the relevant provision of these Regulations;
- (c) amount to be compounded as stated in

these

Regulations;

(d) the date and manner in which such money shall be paid to the Authority; and

(e) any other information as the Authority may deem relevant.

(2) The offender may admit or refuse to have committed the offence to be compounded by signing the Notification Form as prescribed under the Fourth Schedule and Fifth Schedule of these Regulations.

Mode of payment and default

31.-(1) Where the person admits the offence to be compounded, he shall pay the compounded amount within fourteen days to the Authority's bank account physically or electronically and submits the evidence of payment to the Authority's Headquarters or Regional Offices.

(2) Upon submission of the evidence of payment, the

Authority shall issue an official receipt to the licensee in respect of payment received under sub-regulation (1).

(3) Where the licensee fails to pay the compounded amount within the specified time, the Authority shall charge interest of five per centum and five per centum of the accrued amount after every thirty days.

Failure to pay
compounded
amount

32. Where a licensee fails to comply with the order to pay the compounded amount, the Authority may enforce the order in the same manner as a decree of a Court for the payment of the amount stated in the order.

Failure to sign
Notification Form

33.-(1) Where a licensee does not admit the offence alleged to have been committed, he shall, within seven days from the date of commission of such offence submit to the Authority a duly filled Notification Form, as set out in the Fourth Schedule to these Regulations.

Transport Licencing (Motorcycles and Tricycles) (Amendment)

(2) Where a licensee fails to appear at the Authority within the prescribed time he shall be deemed to have admitted the offence and shall be required to pay the penalty as stipulated in these Regulations.

Impounding of motorcycles and tricycles

34.-(1) Where the licensee fails to pay the penalty in regulation 33, the Authority may after thirty days impound and dispose of the motorcycle or tricycle with a view to recovering its fine.

(2) Where the motorcycle or tricycle has been impounded, the operator shall bear any towing and storage costs as well as the costs incurred in the process of impounding the motorcycle.”

Addition of new Third, Fourth and Fifth Schedules

8. The principal Regulations are amended by adding immediately after the Second Schedule the following new Schedules:
