2. The Government of Tanzania has set aside funds for the operation of the Surface and Marine Transport Regulatory Authority during the financial year 2017/18. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Supply of Office Furniture**
3. The **Surface and Marine Transport Regulatory Authority** now invites sealed tenders from eligible **'National'** Suppliers of Office Furniture
4. Tendering will be conducted through the **National Competitive Tendering** procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 as amended in 2016, and is open to all Tenderers as defined in the Regulations.

A complete set of Tendering Document(s) in **English** and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tanzanian Shillings One Hundred Thousand Only (100,000.00)**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Director General.
7. All tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.

All tenders in one original plus Two Copies, properly filled in, and enclosed in plain envelopes must be delivered to the address **Secretary, SUMATRA Tender Board, Procurement Office, Mawasiliano House, Ali Hassan Mwinyi Road/Nkomo Street, on or before Thursday, 12th July 2018 at 1400 hours local time.** Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the the SUMATRA Head Office Conference Room located at Mawasiliano House.
9. Late Tenders, Portion of Tenders, Electronic Tenders, Tenders not received, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
