1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in **Tanzania Procurement Journal** issue No. **1821 – 6021** of **25th June, 2017**
2. The Government of Tanzania has set aside funds for the operation of the **Surface and Marine Transport Regulatory Authority** during the financial year **2017/18**. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Production of Information Dissemination Television Program**.
3. The **Surface and Marine Transport Regulatory Authority** now invites sealed Tenders from eligible **“National”** providers of **Television Programs Services**
4. Tendering will be conducted through the **National Competitive Tendering procedures** specified in the Public Procurement (Regulations, 2013 – Government Notice No. 446 and is open to all Tenderers as defined in the Regulations.

Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the **Secretary SUMATRA Tender Board, Procurement Office, Mawasiliano House, Ali Hassan Mwinyi Rd/Nkomo Street, P.O.Box 3093, Dar es Salaam from 0800 to 1700 local time Mondays to Fridays inclusive except on public holidays**.
6. A complete set of Tendering Documents in **English** and additional sets may be purchased by interested Tenderers on the submission of a written application to

the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tanzanian Shillings One Hundred Thousands Only (TZS.100,000.00)**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Director General

7. All Tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.

All Tenders in one original plus Two Copies, properly filled in, and enclosed in plain envelopes must be delivered to the **Secretary, SUMATRA Tender Board, Procurement Office, Mawasiliano House, Ali Hassan Mwinyi Road/Nkomo Street, on or before Thursday, 12th July 2018 at 1400 local time**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at SUMATRA Head Office Conference Room, Mawasiliano House
9. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, and not opened and not read out in public at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
